Advice to principals regarding MACS boardapproved policies and forms – January 2024

- the current, approved policy version must be used by schools/colleges and published on the school/college website where indicated
- policies/documents must be contextualised by the school/college where indicated
- existing school policies/documents should be checked to ensure they are the current, approved versions
- actions must be completed by the dates indicated below, if no date is indicated the change should be made as soon as practicable
- school communities should be notified of any new or amended policies and procedures via usual modes of school communication.
